This special assessment is now due and payable as your share of the Rockridge Business Improvement District program for the period **January 1, 2018 through December 31, 2018**. The Rockridge BID was voted in by the merchants and business people of the Rockridge District. The BID was formed to promote, improve, and provide additional services to businesses within the Rockridge commercial district and is reviewed annually by the City of Oakland.

Please refer to the **table on the back of this form to determine what your BID payment** is. Your BID payment is based on the type of business and your annual business gross receipts.

**Please write in your prior year's gross receipts and amount due in the box above.**

In order for the program to operate as planned, your payment should be received on or before **March 1st, 2018**. Late payments will be subject to an aggregate total penalty of ten percent (10%) beginning March 2nd and twenty-five percent (25%) beginning May 2nd. In addition to any penalties charged, interest of one percent (1%) per month will continue to accrue on any unpaid balance beginning March 2nd.
